- AFTERNOON HOUR RATE:** \$9.25 for the first hour after school only. Child must be picked up within the first hour after school to get this special rate. \$8.75 for each additional child.
- SHADED DAILY FEE SCHEDULE:** Fee may be adjusted to meet family circumstances.
- DELAYED MORNING START:** Additional \$5.00 charge for morning per child.
- FIELD TRIPS/TRANSPORTATION:** Most costs are included in the daily fee; additional costs are noted on sign-up sheet for trips. When children are transported by rental vehicle, an additional charge will be added to cover the cost of the trip.
- APPLICATIONS FOR REDUCED FEE:** Families applying for reduced sliding fees need to provide three months proof of income at the time of application. Families who are using the Colorado Childcare Assistance Program (CCAP) must show verification from the Larimer County Department of Human Services. All fees are kept at the full fee rate until verification of reduced fees is complete.
- REGISTRATON FEE:** Registration fee for one child is \$55.00 for 2 or more children is \$65.00
